# Rand Abdul Jabar Announced as Winner of 2022 Richard Mille Art Prize at Louvre Abu Dhabi

- Winner awarded \$60,000 in the presence of HE Saood Abdulaziz Al Hosani, Undersecretary of Department of Culture and Tourism - Abu Dhabi, Manuel Rabaté, Director of Louvre Abu Dhabi, and Peter Harrison, CEO Richard Mille Europe Middle East & Africa
- Exhibition and art prize highlights the contemporary art scene in the UAE and GCC

**Abu Dhabi, UAE, 21 March 2023**: Louvre Abu Dhabi and Swiss watchmaking brand Richard Mille revealed **Rand Abdul Jabbar** as the winner of the second edition of the Richard Mille Art Prize at an exclusive ceremony that took place at Louvre Abu Dhabi.

**Rand Abdul Jabbar** was one of ten artists shortlisted to showcase her work, *Earthly Wonders, Celestial Beings (2019 – ongoing)*, in the *Art Here 2022* exhibition in October 2022.

#### **Public**

Born in Baghdad, Rand Abdul Jabbar borrows from and reconstructs the ephemera of place, history, and memory, employing design, sculpture, and installation as primary mediums of operation. Examining and engaging with historic, cultural, and archaeological narratives, she interrogates the fragility of tangible heritage to create and compose forms that draw on artefacts, architecture, and mythology. Simultaneously, she explores and contests with individual and collective memory to produce fragmentary reconstructions of historic events and past experiences.

To date, the artist has had her work exhibited at Shubbak Festival (UK), SAVVY Contemporary (Germany), Rabat Biennale (Morocco), Biennale d'Architecture d'Orléans (France), Abu Dhabi Art, Jameel Arts Centre, NYU Abu Dhabi Art Gallery, and Warehouse 421 (UAE). She has also conducted art residencies with the NTU Centre for Contemporary Art (Singapore), Warehouse 421, the Abu Dhabi Music and Arts Foundation and the Salama bint Hamdan Al Nahyan Foundation (UAE).

**Rand Abdul Jabbar** was selected by a distinguished five-member jury featuring **HH Sheikh Zayed bin Sultan bin Khalifa Al Nahyan**, Chairman of UAE Unlimited, an art collector, and a patron of the Centre Pompidou, the British Museum and Sharjah Art Foundation; **Morad Montazami**, a curator, art historian, publisher and director of Zamân Books & Curating; **Hala Wardé**, founding architect of HW Architecture, long-term partner of Jean Nouvel and the lead of the Louvre Abu Dhabi project; **Dr. Souraya Noujaim**, Director of Scientific, Curatorial and Collections Management at Louvre Abu Dhabi; and **Reem Fadda**, Director of the Cultural Foundation and curator of *Louvre Abu Dhabi Art Here 2022*.

**Dr. Souraya Noujaim, Louvre Abu Dhabi's Scientific, Curatorial and Collections Management Director** said: "The second edition of the Richard Mille Art Prize and Louvre Abu Dhabi Art Here has been a resounding success. The response this year has been outstanding, and I am honoured to be part of the jury that gets to witness this level of creativity and authenticity first-hand. These artists have engaged with the brief so wonderfully, and you can see how the theme of icon and iconic has deeply resonated with them. Through this exhibition, we have been enabled to foster creativity, dialogue, and diversity, further bolstering our mission to identify opportunities that inspires and supports our communities. Providing a platform for artists to demonstrate their work has always been a major tenet for us at Louvre Abu Dhabi, and I am looking forward to seeing all that these artists will achieve in the near future."

For its second edition, *Louvre Abu Dhabi Art Here 2022* invited artists to propose new or existing artworks that engage with the notions of "icon" and "iconic". The artworks explored how the concept of the icon resonates within contemporary art practices and how it informs new artistic perspectives.

Artworks featured in the second edition of *Louvre Abu Dhabi Art Here 2022* included: *Between Desert Seas* (2021) by Ayman Zedani; *Camoulflage: The Fourth Pillar* (2022) by Zeinab Alhashemi; *Wall House* (2022) by Vikram Divecha; *Xylophone* (2022) and the *Reino Plantae* series (2021) by Elizabeth Dorazio; *Sidelines* (2016) by Manal AlDowayan; *Break the Atom and Vegetal Life (After Zeid)* (2022) by Simrin Mehra Agarwal; *Standing by the Ruins* (2022) by Dana Awartani; *Weighing the Line* (2022) by Afra Al Dhaheri; *Earthly Wonders, Celestial Beings* (2019 – ongoing) by Rand Abdul Jabbar; and *A Still Life of an Ever-changing Crop Field* (2022) by Shaikha Al Mazrou.

Louvre Abu Dhabi Art Here is an annual exhibition and art prize which will serve as a platform to showcase contemporary artists from the region working in a variety of media. Each year the exhibition will see several artists selected through an open call for proposals, each exhibiting one artwork in the Forum, a space of interaction and exchange within Louvre Abu Dhabi, dedicated to contemporary art.

The theme of the third edition of the Richard Mille Art Prize and the Louvre Abu Dhabi Art Here exhibition for 2023 is 'Transparency'. Curated by Maya El Khalil, the open call for the upcoming edition will start from 30 March 2023.

#### **ABOUT LOUVRE ABU DHABI**

Created by an exceptional agreement between the governments of Abu Dhabi and France, Louvre Abu Dhabi was designed by Jean Nouvel and opened on Saadiyat Island in November 2017. The museum is inspired by traditional Islamic architecture and its monumental dome creates a rain of light effect and a unique social space that brings people together.
